## Mare Reproductive Contract 2022 Season (Chilled AI)

Between Hunter Equine Centre Pty Ltd and	(mare owner)

It is agreed that the nominated broodmare,	
Will be accepted at the Hunter Equine Centre to be bred to the following nominated Stallion,	

Using live chilled semen and that the mare owner agrees to pay promptly all fees & charges related to this event.

- 1. The mare owner agrees to make separate booking arrangements with the stallion owner and pay for all necessary fees to permit the delivery of chilled semen to Hunter Equine Centre when ordered by the veterinarian attending the mare.
  - The mare owner agrees to pay the procedural fee of \$400 (Exc.GST)
  - The fee is per cycle and includes all ultrasound examinations including pregnancy scans, an ovulation induction agent, artificial insemination and semen analysis, routine uterine treatments (lavage & infusions) and caslick surgery
- 2. Hunter Equine Centre Pty Ltd does not offer any warranty as to the quality of fertility of chilled semen supplied/delivered.
- 3. Hunter Equine Centre Pty Ltd does not accept any responsibility for failure of shipments to meet delivery deadlines and thereby compromise insemination schedules. It should be noted that weekend and public holiday consignments are particularly difficult to secure with regional freight companies and any such shipments are taken on risk by the mare owner.
- 4. Hunter Equine Centre Pty Ltd cannot make any live foal guarantees. Pregnancy certificates are offered on confirmation of a normal ultrasonic scanning at 42 or more days.
- 5. Up to 10% of pregnancies in mares result in twins. The mare owner agrees that this is undesirable and authorises HEC Pty Ltd to undertake reduction procedures to a single conceptus. It is acknowledged that this procedure carries some risk of loss of both embryos. The mare owner accepts that per-rectal examination of mares carries a low risk of inadvertent injury to the mare which may be fatal.
- 6. The mare owner agrees to pay all fees and charges on or prior to contract commencement.

## **2022 AGISTMENT RATES**

- All horses on agistment are fed quality horse hay twice daily.
- Agistment yard/night \$38 (Exc. GST) per night.

If the mare owner cannot be contacted, Hunter Equine Centre Pty Ltd will treat the mare as necessary at the mare owner's expense.
